AN ORDINANCE AUTHORIZING THE EXECUTION OF AN ON-CALL AGREEMENT FOR PROFESSIONAL ENGINEERING & PLANNING SERVICES FOR THE KANSAS CITY - LEE'S SUMMIT REGIONAL AIRPORT (RFQ NO. 2025-064) WITH HDR, INC. FOR ONE YEAR WITH FOUR POSSIBLE ONE-YEAR RENEWAL OPTIONS AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the Federal Aviation Administration and the Missouri Department of Transportation Department - Aviation Division require that Requests for Qualifications (RFQ) be issued once every five years or less; and,

WHEREAS, the City issued RFQ 2025-064 for aviation planning and engineering services on May 5, 2025; and,

WHEREAS, qualification statements were received on June 3, 2025.; and,

WHEREAS, the On-Call agreement provides general scope of services for aviation engineering and planning. It does not contain project specific scopes and fees. As projects are identified and funded, scopes and fees will be negotiated and work authorizations for on-call services will be approved in accordance with the City's Procurement Policy; and,

WHEREAS, HDR, Inc., was determined to be the most qualified by the selection committee.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

- SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves the Agreement, substantially similar to said Agreement attached hereto as "Exhibit A"...
- SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby authorizes the Mayor to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.
- SECTION 3. The Mayor, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.
- SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
- SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
