HEALTH EDUCATION ADVISORY BOARD ACTION LETTER

Thursday, February 23, 2017

I. **Call meeting to order**

The Health Education Advisory Board (HEAB) meeting was called to order at 6:35 p.m. by Dr. Steve Salanski in the Administration Board Room at John Knox Village.

II. **Public comments**

There were no public comments. Dr. Kraemer introduced new Board member, Rhonda Canning with ReDiscover. She previously worked at St. Luke's on the Plaza. Board members introduced themselves.

III. **Approval of January 26, 2017 meeting summary**

The summary was approved with no changes.

IV. **Review of Hands Only CPR training event**

Dr. Salanski thanked City staff for their work. The event was full; all 180 slots were taken. Plus, there was a waiting list. There are no t-shirts left. Ms. Murphy said that there were several inquiries about infant and child CPR training. There was also a lot of interest in AED training. Dr. Salanski speculated that the grant funds have probably been used up but he will confirm that after receiving all invoice totals from the City. Dr. Salanski asked if the Board would like to go after another grant to hold more events in the future. Ms. Stuchlik suggested looking for corporate sponsorship if grant funds are not available. Board members agreed to pursue future events. There was also some interest in offering other kinds of training. Dr. Salanski will work on another grant application.

V. **Distracted Driving Stakeholder Education meeting**

Dr. Salanski said that some emails have been exchanged but they are still working to get a group together.

VI. **Update on Marijuana Legislation Response Task Force**

Dr. Salanski said that there has been some difficulty in scheduling a meeting but it should be set soon. Ms. Schmoeger is interested in joining the Task Force.

VII. Presentation on Eating Disorders

Dr. Kraemer introduced Brad Dirks, Program Director with McCallum Place. Mr. Dirks gave an overview of McCallum Place. They provide partial hospitalization. They have 10-hour day and 6-hour day programs seven days per week. They also offer intensive out-patient programs. Patients must be medically stable to enter the program. Evaluations are done to look for diagnostic criteria and identify the disorder. Mr. Dirks provided printed information. McCallum Place has three locations: St. Louis, Columbia and Kansas City. The Kansas City location is in Overland Park at the Menorah Medical Center campus. Mr. Dirks said that they often provide speakers on eating disorders and would be happy to put together something on a specific topic like recognition and treatment.

VIII. Future continuing education topics

Ms. Meeks will confirm with a speaker on trauma informed care for March. Dr. Kraemer suggested targeting gun safety for the April meeting. Mr. Feldman will check on speakers.

IX. Media articles

Board members expressed their appreciation for February's article on the tenth anniversary of the Clean Indoor Air Act. Dr. Kraemer will coordinate with Mr. Dirks for an article on eating disorders for March. Dr. Kraemer provided a list of observances in April and May. Ms. Walz offered to work on a topic and author for National Public Health Week in April. Ms. Rodgers offered to provide an article on Stroke Awareness for May.

X. HEAB Facebook page update

Ms. Stuchlik said that posts surrounding the CPR event had good dispersion. She provides links to the Board's articles after they are put online by the newspapers.

XI. City Council presentation

Mr. Feldman said that the March agendas are pretty full. He will follow up. The Board will be giving the City Council an overview of the community health assessment results, the program devised from those results, and recent Board activities.

XII. Roundtable

Ms. Walz said that Jackson County is working on another community health assessment.

Ms. Rodgers stated that St. Luke's East has a permanent drug take back box near the ER.

Dr. Salanski said there are two bills of interest in the Missouri Legislature on prescription drug monitoring. One bill creates a program similar to those in other states and is supported by the Medical Society. The other bill is being pushed very strongly but it does not include enough information, only a "red light/green light" system that could add delays for medication.

Ms. Meeks stated that LS CARES has signed a resolution in support of a prescription drug monitoring program.

Dr. Kraemer said that there will be an open house meeting series on the Rock Island Pedestrian and Bike Path. A meeting will be held in Lee's Summit at Longview Community College on Mar. 8, from 5:30 to 7:00 p.m.

Ms. Meeks provided a list of bills and their status in the Missouri Legislature, regarding: alcohol, distracted driving, marijuana, mental health, tobacco, and prescription drugs. She also shared copies of the February Shape Up newsletter.
