A. 2025-6993 Approval of the May 12, 2025 Legislative and Intergovernmental Relations Committee Action Letter.

B. 2025-6975 Presentation: Lobbyist report - End of Missouri Legislative Session.

Our Legislative Lobbyists from Versa Governmental Strategies gave an update to the Committee on the Legislative Session. They mentioned that today (July 14, 2025) is the final day for the Governor to take action. The Lobbyists will present final information at the City Council Meeting on July 15, 2025).

Some of the Bills that passed included:

- 1. HB105: (Conveyance of land): Included language from Lee's Summit relative to 291 Hwy & 50 Troop A.
- 2. HB8: (Thanks to the Speaker of the House, along with other representatives) this Bill PASSED which included \$3.5M for joint operations center and inoperable communication.
- 3. SB145: Prohibits municipality from licensing, taxing or regulating any sort of business enterprise owned by a person 18 years or younger.
- 4. HB145 (Sunshine Law): Allows for the closure of certain records including individually identifying information of a minor.
- 5. HB199: Several items that impact municipalities.
- 6. HB567: Repealed the voter approved scheduled future adjustments to the state minimum wage and sick leave requirements.
- C. 2025-6941 Continued discussion: Potential of Federal Lobbyist

Brian Head discussed the previous request by the Committee to research what would be involved in hiring a Federal Lobbyist. He also invited our Lobbyists to weigh in on the discussion.

The discussion revolved around:

- 1. Pros and Cons of hiring a Federal Lobbyist, and
- 2. Different types of Federal Lobbyists (generalist or topic specific), and
- 3. If there is a possible cost share opportunity with neighboring cities

After brief discussion, the Committee asked Staff to do further research relative
