AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH CONSTANT TECHNOLOGIES FOR AUDIO-VISUAL VIDEO WALL DISPLAY, DISPATCH FEEDS, ANALYTICS, AND SECURE COMMUNICATION INFRASTRUCTURE INCLUDING EQUIPMENT, FURNITURE AND SERVICES IN THE JOINT OPERATIONS CENTER IN A NOT TO EXCEED AMOUNT OF \$1,557,824.75 FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the Joint Operations Center requires customized technology, systems integration, furniture and installation for efficient operations,

WHEREAS, this Sole Source award is based on Constant Technologies abilities in system integration and compatibility; continuity of emergency operations; specialized technical knowledge and time sensitivity and security requirements.

WHEREAS, the City desires to enter into an agreement with Constant Technologies to provide the Joint Operations Center with integrated systems including audio-visual wall display, dispatch feeds, analytics, and secure communication infrastructure using standardized equipment and professional services.

WHEREAS, the integration and compatibility of the Joint Operations Facility's Emergency Operations Center with the Real Time Crime Center is in the public interest and necessary for secure and seamless delivery of first responder services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The contract attached hereto as Exhibit A (the "Agreement"), is hereby approved in a not to exceed amount of \$1,577,824.75 and the City Manager is authorized to execute the Agreement in substantial compliance with the attached version. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the Project for the City. Such changes may include changes to the Agreement, provided that the price paid for the services and the other items which constitute the consideration do not change.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
