B. <u>BILL NO.</u> 23-252

An Ordinance authorizing the execution of a Memorandum of Understanding by and between the City of Lee's Summit, Missouri and the Blue Springs R-IV School District for the IMPACT program. (CEDC 12/13/23)

Major Nicole Walters, Police Department, explained the City of Lee's Summit received a grant from the Jackson County COMBAT Drug Commission for the IMPACT program, which is an anti-drug and stress management curriculum that teaches elementary students to resist the use of tobacco, alcohol, marijuana, and vaping, and provides students an understanding of the skills to manage stress, resist peer pressure, and control emotions during conflicts.

Through the COMBAT grant and City funding, the City provides law enforcement officers who teach the IMPACT curriculum to LSR7 District elementary schools.

The IMPACT program also benefits students attending Chapel Lakes and Voy Spears Jr. Elementary Schools. While both schools are located in Lee's Summit city limits, they are in the R4 Blue Springs School District boundary. Therefore, staff is seeking approval of an MOU between the City of Lee's Summit and the R4 School District to provide the IMPACT program to these schools using Lee's Summit law enforcement officers.

Vice Chair Prier made a motion, seconded by Councilmembr Hodges, to recommend for approval an Ordinance authorizing the execution of a Memorandum of Understanding by and between the City of Lee's Summit, Missouri and the Blue Springs R-IV School District for the IMPACT program.

**C.** 2023-6008

Discussion: Amendment to Chapter 33, Unified Development Ordinance, of the Lee's Summit Code of Ordinances, Article 9, Division III, V, and IX, by updating the requirements for temporary signs.

Josh Johnson, Director of Development Services, provided background information on the requested amendments and reviewed the different types of signs. He presented a comparison of temporary sign and yard sign requirements of other metropolitan cities which included Blue Springs, Lenexa,

Olathe and Overland Park.

The purpose of the amendments are to improve readability and remove inconsistencies, focus on sign type instead of content, and establish time duration requirements.

Mr. Johnson provided a redline version of the proposed amendments for the committee to review and stated staff is seeking direction to draft language to be used to begin the public hearing process.

After discussion, the committee directed staff to proceed to the Planning Commission with the amendments.

### 6. Roundtable

Councilmember Hodges requested a discussion on design standards for a future agenda item. Mr. Johnson stated staff could prepare an outline on how those are executed. Chair Edson shared that Councilmember Felker has requested numerical information on multi-family and single-family data.
