AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE AERIAL LIFT TRUCK FOR THE PUBLIC WORKS TRAFFIC DIVISION AND THE USE OF APPROVED SOURCEWELL CONTRACT #110421-TIM AND LEE'S SUMMIT CONTRACT #2025-044 FOR THE PURCHASE OF THE CAB AND CHASSIS NOT TO EXCEED \$196,941.62 AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the Fleet Division in cooperation with the Public Works Traffic Division has recognized the need to replace the existing aerial lift truck which has reached its useful life cycle; and

WHEREAS, ordering this unit from the approved Sourcewell and LS contracts is the most costeffective way of securing the correct equipment and built to our specifications; and

WHEREAS, the Fleet Manager, the Department Director and the City Manager seek approval from the City Council to use the approved contract for the purchase of this piece of equipment and not to exceed \$196,941.62; and

WHEREAS, funding has been identified for the purchase of this unit in the City Council approved Fleet VERP FY26 Budget; and

WHEREAS, Section 4 of the Procurement Policy requires City Council approval to use contracts where the anticipated annual spend is \$75,000 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Manager is hereby authorized to purchase from the existing Sourcewell contract for one aerial lift truck from Aspen Equipment company as described in Exhibit A attached and in the amount of \$196,941.62 total for the aerial lift and the cab and chassis. The City Manager is authorized to execute all necessary documents to proceed with this purchase. The City Council hereby delegates authority to City Manager to negotiate such changes to the Contract and its exhibits as are necessary to complete the Contract and carry out its purposes and intent for the City, provided the price does not exceed the purchase price of \$196,941.62 as approved by the City Council.

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
