In response posed to him by a neighbor, Board Member Benbrook inquired about the process for requesting an additional streetlight.

Susan Barry, City Traffic Engineer, stated that once a request is submitted, city staff reviews the request to see if the existing street lighting meets the existing policy or if additional lighting is warranted. If additional lighting is warranted the request is forwarded to Evergy where the installation of new lights can take up to eight months. Follow up is recommended by both the neighbor and the city.
