AN ORDINANCE REPEALING ORDINANCE NO. 10284 AND APPROVING AN AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND THE MISSOURI DEPARTMENT OF PUBLIC SAFETY FOR THE CITY'S ACCEPTANCE OF APPROPRIATED FUNDS IN THE AMOUNT OF \$2,000,000 FOR THE PLANNING, DESIGN AND CONSTRUCTION OF AN EMERGENCY OPERATIONS FACILITY PURSUANT TO HOUSE BILL 8, SECTION 8.133, FISCAL YEAR 2026 AND AUTHORIZING THE MAYOR TO EXECUTE ANY AND ALL DOCUMENTS FOR THE SAME BY ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit (the "City") is a political subdivision of the State Missouri in which City is located and is duly organized and existing pursuant to the constitution and laws of the State of Missouri; and,

WHEREAS, the City's is currently in the process of constructing a new Joint Operations Facility, and,

WHEREAS, the State of Missouri has appropriated funding via HB8, Section 8.134, Fiscal Year 2026 to assist in the delivery of the Joint Operations Facility; and,

WHEREAS, The Department of Public Safety (DPS) intends to authorize payment to the City of Lee's Summit pursuant to the noted Appropriation and in accordance with the provisions noted in Exhibit "A", and,

WHEREAS, The City Council previously passed Bill No. 25-245 and now needs repealed,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council hereby repeals Bill No. 25-245 and approves an agreement between the City of Lee's Summit and the Missouri Department of Public Safety, attached hereto as Exhibit A, for the City's acceptance of appropriated funds in the amount of \$2,000,000 for the planning, design, and construction of an emergency operations facility pursuant to House Bill 8.133, Fiscal Year 2026, and authorizing the Mayor to execute any and all documents on behalf of the City for the same. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the Project for the City, provided that the price paid for the services and the other items which constitute the consideration do not change.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
