## **BILL NO. 25-186**

AN ORDINANCE CREATING ARTICLE 6 IN CHAPTER 26 OF THE CITY CODE TO PROVIDE FOR THE DELEGATION OF AUTHORITY TO CITY STAFF FOR THE MANAGEMENT, OPERATIONS, SECURITY, MAINTENANCE AND UPKEEP OF GREEN STREET.

WHEREAS, the City Council desires to ensure that the City Manager and his or her designees among City staff have clear authority from the City Council to provide for the operations, management, maintenance and security of Green Street; and,

WHEREAS, the City Council desires to ensure that adequate guidance and standards are provided by the City Council to the City Manager and other City staff to manage and operate Green Street in accordance with all legal requirements and applicable City Code provisions; and,

WHEREAS, it is the intent of the City Council to allow City staff to provide for the operation, management, maintenance, upkeep, cleanliness and security of the Green Street facilities in accordance with the provisions of a new Article in the City Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. Chapter 26, Streets, Sidewalks and Other Public Places, of the City's Code of Ordinance is hereby amended by adding a new Article 6, Delegation of Authority to City staff to Manage and Operate Green Street, pursuant to the document set forth in the attached Exhibit A which is incorporated herein by reference. The attached provisions in Exhibit A shall be added to the City Code.

SECTION 2. This Ordinance shall be in full force and effect from and after its passage, adoption, and approval by the Mayor.
