AN ORDINANCE APPROVING A SOFTWARE SUPPORT AGREEMENT FOR THE CIS INFINITY SOFTWARE BETWEEN THE CITY OF LEE'S SUMMIT AND N. HARRIS COMPUTER CORPORATION IN THE AMOUNT OF \$246,080.12, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit, Missouri ("City") and N. Harris Computer Corporation (the predecessor in interest to Advanced Utility Systems) ("N. Harris") executed a Software License, Implementation and Support and Maintenance Agreement in 2010 ("Software and Maintenance Agreement") whereby the City received a license to N. Harris' CIS Infinity software and the accompanying maintenance and support services; and,

WHEREAS, the City relies on the CIS Infinity system for core functions of the Water Utilities Department; and,

WHEREAS, in 2017, pursuant to Ordinance 8154, the City and N. Harris amended the Software and Maintenance Agreement to allow the City to continue receiving software maintenance services; and,

WHEREAS, the City and N. Harris to desire to amend and restate the Software and Maintenance Agreement to updates the terms of service and allow the City to continue receiving software maintenance services; and,

WHEREAS, maintaining a support contract with N. Harris allows the City to access system help and assistance, system improvements, fixes, security patches updates, and upgrades.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council approves an agreement between the City of Lee's Summit and N. Harris Computer Corporation, attached as Exhibit A and incorporated herein by reference, for software system support and maintenance services over a five-year period for a cost not to exceed \$246,080.12 over the life of the agreement, and authorizes the City Manager to execute the same, in substantially the same form as the attached, on behalf of the City.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
