AN ORDINANCE APPROVING THE AWARD OF RFP NO. 2024-022 FOR TOW SERVICES FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE YEAR RENEWALS TO JAMES R. MCCOY LLC D/B/A JIM'S TOW SERICE AS THE PRIMARY AWARDEE AND RON'S AUTO AND TOW TRUCK TOWING, LLC AS THE SECONDARY AWARDEE AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit ("City"), through the Procurement and Contract Services Division, issued RFP No. 2024-022 for tow services on an as-needed basis for Cityowned vehicles and use by the Police Department during traffic-related incidents; and,

WHEREAS, RFP 2024-022 was advertised through the City's e-procurement system, Public Purchase, and sent to twenty-nine (29) potential suppliers through email and Public Purchase; and,

WHEREAS, as of the close of the period for submissions, a total of five tow companies submitted proposals; and,

WHEREAS, based upon the evaluation of responses, as well as the review by the Tow Committee and the Public Safety Advisory Board, the project evaluation committee recommended awarding RFP No. 2024-022 for tow services for a one-year term with up to four, one-year renewals to James R. McCoy LLC d/b/a Jim's Tow Service as the primary awardee and Ron's Auto & Tow Truck Towing, LLC as the secondary awardee.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby authorizes the award of RFP No. 2024-022 for tow services for a one-year term with up to four, one-year renewals to James R. McCoy LLC d/b/a Jim's Tow Service as the primary awardee and Ron's Auto & Tow Truck Towing, LLC as the secondary awardee.

SECTION 2. The agreement by and between the City and James R. McCoy LLC d/b/a Jim's Tow Service as the primary awardee and Ron's Auto & Tow Truck Towing, LLC as the secondary awardee as described in RFP no. 2024-022, a true and accurate copy of the same being attached hereto as "Exhibit A" and "Exhibit B" and incorporated herein by reference be and is hereby approved, and the City Manager is hereby authorized to execute such agreement or substantially similar by and on behalf of the City.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
