AN ORDINANCE APPROVING CHANGE ORDER NO. 1 TO THE AGREEMENT WITH KISSICK CONSTRUCTION COMPANY INC. FOR THE CIPP LINING AND LCRs, AS PART OF THE I/I REMOVAL - CIPP LINING, MANHOLE REHAB, AND LCRs - FY24, PROJECT NO. 962-2, FOR AN INCREASED AMOUNT OF \$ 683,610.00 FOR A REVISED AGREEMENT AMOUNT OF \$1,917,532.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 10017, the City and Kissick Construction Company, Inc. (hereinafter "Contractor") entered into an agreement for the construction of the Project CIPP Lining and LCRs Project No. 962-2, as part of the I/I Removal - CIPP Lining, Manhole Rehab, and LCRs - FY24 (hereinafter "Base Agreement"); and,

WHEREAS, the City desires to modify the Base Agreement, as amended, to increase the cost due to additional costs associated with added work, including adding items for Lateral Connection Repair (LCR) work to use all ARPA Legislative Priority Grant money available to the City of Lee's Summit.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. Change Order No. 1 to the Base Agreement, as amended, with the Contractor, an increase of \$683,610.00 for a revised amount of \$1,917,532.00, attached hereto as Exhibit A and incorporated by reference, is hereby approved, and the City Manager, or designee, is hereby authorized to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
