

## **BILL NO. 25-131**

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE THE ORDER FORM FOR THE SUBSCRIPTIONS WITH WORKDAY FOR A NOT TO EXCEED AMOUNT OF \$250,689 IN FY26 TO INCLUDE SOFTWARE MODULES ENABLING THE CITY TO OBTAIN THE STRATEGIC SOURCING EXPERT, WORKDAY CONTRACT LIFECYCLE MANAGEMENT, CONTRACTS INTELLIGENCE AND 5 CUSTOM AI MODELS AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE ANY SUBSEQUENT DOCUMENTS NECESSARY TO OBTAINED THE SAME SERVICES FOR THE TERM OF THE MAIN SUBSCRIPTION AGREEMENT SUBJECT TO THE FISCAL YEAR BUDGETS.

WHEREAS, the City of Lee's Summit, Missouri is a constitutional charter City, organized and existing under the laws of the State of Missouri (hereinafter "City"); and,

WHEREAS, the City currently maintains Workday provides the city with the Enterprise Resource Planning (ERP) Human Capital and Financial Management System under Main Subscription Agreement #00443444.0; and,

WHEREAS, the City desires to enter into a subscription order to obtain the Modules (Intake; Pipeline; Sourcing; Contracts; Supplier Management and Reporting) Workday solution and brings forth the contract for approval.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Order Form which is attached hereto as Exhibit A in the amount of \$250,689 in FY26 and incorporated herein by reference (the "Agreement"), is hereby approved and the City Manager is authorized to execute the Agreement in substantial compliance with the attached version. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the Project for the City. Such changes may include changes to the Agreement, provided that the price paid for the services and the other items which constitute the consideration do not change.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
