## Commentary

The applicant requests approval for one (1) ground sign that is larger than the maximum size allowed by the Unified Development Ordinance (UDO). The proposed sign will be painted white with etched blue copy, mounted between aluminum white posts with white ball finials. The maximum allowable ground sign size in the PMIX (Planned Mixed Use District) is 16 sq. ft. The applicant proposes a 37 sq. ft. ground sign. The UDO grants the Planning Commission the authority to consider applications for signs that exceed the maximum allowed sign area. Staff supports the requested larger sign.

### Recommendation

Staff recommends APPROVAL of the sign application.

# **Background**

- January 21, 2016 The City Council approved the preliminary development plan (Appl. #PL2015-132) for The Goddard School by Ordinance No. 7802.
- August 22, 2016 The final development plan (Appl. #PL2016-079) for The Goddard School was administratively approved by Staff.

# **Analysis of Sign Application**

**Ordinance.** The Unified Development Ordinance, Article 13, Table 13-1, sets standards for the maximum allowable sign area, but authorizes the Planning Commission to consider and approve larger signs. The standard for a ground sign in the PMIX zoning district is a maximum of 16 sq. ft.

**Request.** The applicant proposes a 37 sq. ft. ground sign. The sign will be painted white with etched blue copy, mounted between aluminum white posts with white ball finials. The sign will be located along SW Longview Drive near the drive entrance of the school.

**Recommendation.** Staff recommends approval of the ground sign as proposed. While the UDO allows for up to a 72 sq. ft. monument sign composed of a sign cabinet sitting upon a solid masonry base to be constructed on the subject property, staff believes the proposed ground sign to be proportionally sized for the site and to be a more appropriate choice. The 37 sq. ft. ground sign's design aesthetic borrows from the look of traditional ranch rail fencing, which perfectly ties into the area's history as Longview Farm.
