**D.** 2024-6068 Review of 5-year Public Hearing presentation

The purpose of the hearing is to determine if the authority is making satisfactory progress under the proposed time schedule contained within the approved plans for completion of such projects.

Mr. Elam stated the next Public Hearing is scheduled for February 6, 2024. He proceeded to present the draft presentation and asked the LCRA members to provide input on suggested changes or additions to the presentation.
