## **BILL NO. 24-140**

AN ORDINANCE AUTHORIZING THE PURCHASE OF THREE BMW TRAFFIC ENFORCEMENT MOTORCYCLES FOR THE AMOUNT OF \$90,957.66 AS A SOLE SOURCE AGREEMENT AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED AND NECESSARY DOCUMENTS.

WHEREAS, the Fleet Division in cooperation with the Police Department has recognized the need to to replace three existing BMW motorcycles units due to the existing units reaching the end of its lifecycle; and,

WHEREAS, Engle Motors inc. is the only BMW dealer capable of building the specially designed motorcycles that meet all the needs of the Police Department Traffic Division; and,

WHEREAS, the Fleet Manager, the Department Director and the City Manager have approved this purchase as a sole source agreement; and,

WHEREAS, funding has been identified through the previously City Council approved FY25 Fleet VERP Budget; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if the contract has or is anticipated to have an annual spend more than \$75,000.00.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the Purchase of three BMW Motorcyles in the amount of \$90,957.66 from Engle Motors of Kansas City as set for the in Exhibit "A" attached hereto, and authorizes the City Manager to execute the necessary and required documents by and on behalf of the City of Lee's Summit

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
