AN ORDINANCE ENACTING NEW SECTION 2-3 OF THE MUNICIPAL CODE TITLED BONDS FOR OFFICERS AND EMPLOYEES PROVIDING FOR THE BONDING OF CERTAIN OFFICERS AND EMPLOYEES.

WHEREAS the Council recognizes the Charter in Section 14.6 empowers the Council to designate such officers and employees of the city as the Council shall deem necessary and appropriate to be bonded in the performance of their duties, and;

WHEREAS the Charter in Section 7.3 requires bonds for municipal court employees as may be required by the judges or as the Council shall deem necessary in the performance of their duties, and;

WHEREAS the Council desires to specify those officers and employees to be bonded in the performance of their duties and set out the amounts of the bonds for those positions, and:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. There is hereby enacted a new Section 2-3 of the Code of Ordinances of the City of Lee's Summit, Missouri, to read as follows:

Section 2-3 Bonds for Officers and Employees

A. The following officers and employees of the city shall be bonded in the following amounts:

<u>Position</u>	<u>Amount of Bond</u>
1. City Manager	\$250,000.00
2. Director of Finance	\$250,000.00.
3. Deputy Directors of Finance (2)	\$250,000.00.
4. Judge of the Lee's Summit Municipal Division	\$50,000.00
5. Municipal Division Court Administrator	\$50,000.00
6. Municipal Division Court Clerk Supervisor	\$50,000.00
7. Senior Court Clerk	\$50,000.00
8. Court Clerk	\$50,000.00
9. Court Bailiff	\$50,000.00

- B. The City Manager is hereby authorized to require and obtain bonds for such other officers and employees of the City, in such amounts, as may be necessary in the City Manager's opinion to safeguard the finances of the City.
- C. The City Manager shall obtain bonds for such employees of the Lees Summit Municipal Court, and in such amounts, as may be requested by the Presiding Judge of that court.
- D. The Council finds that individuals involved in receiving money in a direct transaction on behalf of the city including, but not limited to receiving money required under the city's Schedule of Fees or for utility payments, permit fees, police reports, open records requests, promotional items, food and beverages or collecting funds for admission to city facilities are exempt from the necessity of being bonded.
- E. The city shall pay the premiums on all such bonds required under this ordinance or under the authority delegated herein to the City Manager.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.

SECTION 5. This Ordinance shall be codified and set out in full in the "Code of Ordinances of the City of Lee's Summit, Missouri.
