**C.** BILL NO. 25-189

An Ordinance Amending Chapter 29 of the Lee's Summit City Code of Ordinances, Article 1, Section 29-12 Pertaining To Establishment of Play Streets and Amending Article VI, Division 2, Section 29-452 Pertaining to Parade Applications for a specified time period during the 2026 FIFA World Cup. (CEDC 9/10/25)

Tracy Albers, Director of Development Services, presented information about this proposed amendment in preparing for the 2026 FIFA World Cup. She explained this is a companion piece to the Unified Development Ordinance (UDO) Amendments that were considered by the Community and Economic Development Committee (CEDC) in August. This draft Ordinance would amend City Code and temporarily modify the regulation of play streets (block parties) and parades, whereby no parade or block party permits would be issued from June 1 - July 31, 2026, with the exception of those for City-sponsored and/or FIFA events.

- 5. Concept Plans submittal requirements

#### **Zoning Reform Areas**

- 1. L and Use Entitlements expanding housing choice
- 2. New Conventional Zoning District (R-2)
- 3. Public Hearings-number of hearings for P DP s and revised PDP
