

## **BILL NO. 23-018**

AN ORDINANCE APPROVING THE AWARD OF RFQ NO. 2023-020 FOR PROFESSIONAL ENGINEERING SERVICES FOR THE TUDOR ROAD PUMP STATION FACILITY PLAN PROJECT TO HDR ENGINEERING, INC. FOR AN AMOUNT NOT TO EXCEED \$150,000.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the City Council formally programmed funding for the Tudor Road Pump Station ("Project") as part of the FY2023 Capital Improvements Plan (CIP); and,

WHEREAS, City Staff issued RFQ No. 2023-020 to conduct a qualification based selection for professional engineering services, in accordance with state statutes and local procurement policies; and,

WHEREAS, after reviewing the submissions for RFQ No. 2023-020, HDR Engineering, Inc. ("Engineer") was determined to be the most qualified firm to undertake such an assignment; and,

WHEREAS, following successful scope and fee negotiations, the City desires to enter into an agreement with Engineer for the Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves the award of RFQ No. 2023-020 to the Engineer for an amount not to exceed \$150,000.00 for the Project.

SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby authorizes the City Manager, or designee, to execute an Agreement for Professional Engineering Services, substantially similar to the attached Exhibit 1, incorporated herein by reference, with the Engineer for the Project.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
