

RESOLUTION NO. 26-04

A RESOLUTION CANVASSING AND DECLARING THE RESULTS OF THE APRIL 7, 2026, REGULAR MUNICIPAL ELECTION FOR MUNICIPAL OFFICERS FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, a Regular Municipal Election was held in the City of Lee's Summit, Missouri, on April 7, 2026; and,

WHEREAS, the official return of the election has been received from the Jackson County Board of Election Commissioners, certified by such board; and,

WHEREAS, the official return of the election has been received from the Election Authority of Cass County, certified by such authority; and,

WHEREAS, the Council of the City of Lee's Summit, Missouri wishes to canvass and declare the results and effect of the election described above as provided by Section 9.3 of the Charter of the City of Lee's Summit, Missouri.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the election conducted in the City of Lee's Summit, Missouri on April 7, 2026, is found to have been held in all respects as required by the Constitution and the law of the State of Missouri and the Charter of the City of Lee's Summit, Missouri at designated voting places; that duly qualified electors of the City of Lee's Summit and no others were permitted to vote and that the official return of the election, as submitted by the Jackson County Board of Election Commissioners attached hereto as Exhibit "A" and Election Authority of Cass County attached hereto as Exhibit "B" is as follows:

SECTION 2. That the official return of the election, as submitted by the Jackson County Board of Election Commissioners for candidates seeking the office of Mayor, Councilmember for Districts 1, 2, 3 and 4; and, for Municipal Judge, Division 243, is as follows:
