

## **BILL NO. 25-187**

AN ORDINANCE APPROVING THE GREEN STREET USE AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND DOWNTOWN LEE'S SUMMIT MAIN STREET, INC.

WHEREAS, The City of Lee's Summit, Missouri developed Green Street and the Green Street Market for the benefit of the public and desires to see the Green Street Market used for farmers markets and additional programming; and,

WHEREAS, Downtown Lee's Summit Main Street is a critical community partner in the development and use of Green Street; and,

WHEREAS, Downtown Lee's Summit Main Street runs a public farmers market in Lee's Summit and desires to use Green Street for the Downtown Lee's Summit Main Street Farmers Market; and,

WHEREAS, The City of Lee's Summit, Missouri and Downtown Lee's Summit Main Street desire to enter into the attached Green Street Use Agreement to outline the use of Green Street for regular Downtown Lee's Summit Main Street Farmers Market programming.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Use Agreement, attached hereto as Exhibit A and incorporated by reference, between the City of Lee's Summit, Missouri and Downtown Lee's Summit Main Street, is hereby approved.

SECTION 2. The Mayor is hereby authorized to execute the Use Agreement described herein above and attached as Exhibit A. Further, the Mayor and City Manager as may be required, are hereby authorized to take such further action and execute such other documents, instruments and use agreements as may be necessary or desirable to carry out and comply with the intent of this Ordinance, and to carry out, comply with and perform the duties of the City with respect to the use of Green Street.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
