- B. [2026-7453](#) Presentation: Lobbyist Update

Mr. Jon Hensley and Mr. Zach Pollack updated the Committee on the status of Legislative items that may impact municipalities.

Some of the bills discussed were:

1. HB 2761 and SB1586 - Relative to Solid Waste Management.
2. HB 2155 and SB 1065: Creates provisions relating to utility facility relocation. This bill would require municipalities, counties and MoDot to reimburse non-regulated utilities (telecoms) on labor costs associated with relocation as part of the cost of the road project.
3. SB 1087: Modifies provisions relating to drivers licenses - Limiting driving privileges for those that fail to appear or to pay any fines or court costs. 65
4. HB 3147 and SB 927: Creates new provisions relating to the sale of Kratom in Missouri.
5. HB 2641: Creates provisions relating to cannabis
6. HB 3283 and HB 3306 (identical bills - 2 different representatives:) Modifies provisions relating to public labor organizations
7. HJR173: Govenor's Top Priority - headed to Senate: Potentially Phasing out Missouri individual income tax based on State revenue growth.

Councilmember Shields asked if the City should be concerned about any of the bills at this time. Mr. Hensley mentioned that if SB1065 gets out of the Senate, the City would need to contact our Representatives. They will keep us apprised if that happens. Councilmember Shields mentioned she would be happy to contact them as needed and Christal Weber mentioned having staff work on some talking points (numbers and project impacts) should that bill move forward.

Mr. Pollack felt it would be beneficial if he could get information now to give to

Senator Henderson.

There was also a question regarding the budget. Mr. Pollack mentioned that the Speaker is aware of the City's requests and wants to help Lee's Summit, however there are a multitude of cuts this year and doesn't know if that will happen.

Mr. Hensley and Mr. Pollack will keep the Committee updated on the status of the bills as they move through the Legislative process.

Mr. Hensley and Mr. Pollack left the meeting at 12:24 p.m.
