AN ORDINANCE AUTHORIZING EXECUTION OF MODIFICATION NO. 5 TO THE AGREEMENT WITH CRAWFORD MURPHY AND TILLY, INC. FOR ON-CALL ENGINEERING SERVICES FOR THE AIRPORT (RFQ 2015-300) IN THE AMOUNT OF \$376,596.01 FOR DESIGN ENGINEERING SERVICES FOR TAXIWAY PAVING OF TAXIWAY ALPHA AND OTHER INCIDENTAL WORK.

WHEREAS, through RFQ 2015-300, the City of Lee's Summit ("City") has an agreement with Crawford Murphy and Tilly, Inc. ("CMT") for on-call engineering services for the Lee's Summit Municipal Airport (the "Airport"); and,

WHEREAS, this Modification No. 5 to the City's on-call engineering services agreement with CMT is for Design Engineering Services for Taxiway Paving of Taxiway Alpha and other incidental services (the "Project"); and,

WHEREAS, the Project includes engineering design for grade and pave Taxiway A (4,550 feet by 35 feet), 5 connecting taxiways to Runway 18/36, storm drainage system, taxiway lighting and signage, and other incidental work.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the City Manager on behalf of the City of Lee's Summit, Missouri, of Modification No. 5 to the agreement with Crawford Murphy and Tilly, Inc. for on-call engineering services for the Lee's Summit Municipal Airport (RFQ 2015-300) in the amount of \$376,596.01, which is attached hereto and incorporated by reference as if fully set forth herein.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
