

## **RESOLUTION 20-10**

---

A RESOLUTION APPROVING THE APPLICATION FOR AND ACCEPTANCE OF PUBLIC HEALTH AND SOCIAL SERVICES EMERGENCY FUNDS DISTRIBUTED PURSUANT TO THE CARES ACT, AND AUTHORIZING THE MAYOR TO EXECUTE ANY AND ALL FORMS NECESSARY TO APPLY FOR AND ACCEPT THE SAME ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was enacted on March 27, 2020, and provides funding for various entities in response to the 2019 novel coronavirus ("COVID-19"); and

WHEREAS, among other things, the CARES Act allocated money to the Public Health and Social Service Emergency Fund ("Relief Fund") to assist healthcare providers who diagnose, test, or care for individuals with possible or actual cases of COVID-19, and to help providers recoup their expenses and lost revenues; and

WHEREAS, the U.S. Department of Health and Human Services automatically distributed money from the Relief Fund to the City of Lee's Summit, Missouri ("City") because the City, through its Fire Department, billed Medicare in 2019 and has provided and continues to provide care for individuals with possible or actual case of COVID-19; and

WHEREAS, the City is eligible to apply for additional money from the Relief Fund; and

WHEREAS, to keep the money from the Relief Fund, the City must sign an attestation agreeing to the terms and conditions associated with the Relief Fund; and

WHEREAS, the City desires to keep the money from the Relief Fund, apply for additional money from the Relief Fund, and authorize the Mayor to sign the attestation agreeing to the terms and conditions associated with the Relief Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT AS FOLLOWS:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's acceptance of the terms and conditions associated with the Public Health and Social Service Emergency Fund ("Relief Fund") and authorizes the Mayor to execute any and all documents related to applying for and accepting money from the Relief Fund.

SECTION 2. This Resolution shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Resolution be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
