B. <u>BILL NO.</u> 24-042

An Ordinance amending the Code of Ordinances section 12-4. Use of City staff and resources prior to an election to modify the terms thereof to coincide with the first date of candidate filing.(Rules Committee 2/15/24)

At the previous City Council Rules Committee meeting, Brian Head was asked to create a draft ordinance modifying Section 12-4, "Use of City Staff and resources prior to an election".

The Committee discussed the modification to the ordinance which moved the date from "Feb 1, of any general municipal election year until after such election" to "the first day for candidate filing for a City Municipal Office."

This item was discussed briefly and an additional change was made to be consistent in the second WHEREAS, by changing City Council to City Municipal Office.

Councilmember DeMoro made a motion to advance TMP-2925 to the full council with a recommendation of approval an ordinance amending the code of ordinances Section 12-4. Use of City staff and resources prior to an election to modify the terms thereof to coincide with the first date of candidate filing. Seconded by Councilmember Edson. Motion passed 4-0.
