3. Council Roundtable

Councilmember Edson noted that many meetings and events have been cancelled or postponed. Among those were the graduation ceremonies for our local high schools. Those events have now been scheduled as follows: St. Michael's - June 16th; Summit Christian Academy - June 20th; Lee's Summit High School, Lee's Summit North and Lee's Summit East are all scheduled for July 25th; and, Blue Springs South is May 24th.

Councilmember Johnson asked if there was any current direction on social gathering restrictions being lifted by the County Executive. Mr. Steve Arbo, City Manager, advised the current date of reducing restrictions is May 15th for Jackson County. There has not been any direction given past that date at this time.

Councilmember Binney asked if the City was making preparations to start opening everything up again as it will take time for small businesses to create plans, order supplies, and direct employees. Mr. Arbo stated Jackson County is the expert on this information and the City is following their guidelines and regulations as best practices. There has not been any direction given on reopening at this time other than the date of May 15th to lift the stay at home orders.

Mayor Baird encouraged those involved with MARC and working with Jackson County to continue to push for more information, dates, guidelines on reopening the City so that both the City and businesses can start planning.

Mr. Mike Snider, Fire Chief, provided an update on the COVID-19 pandemic as it relates to Jackson County and Lee's Summit. He stated reopenings will be done in multiple phases and there will be more information coming forward regarding dates, social distancing guidelines, timelines, etc. It will take some time to recover from this and it will be a slow process to get to a new normal.
