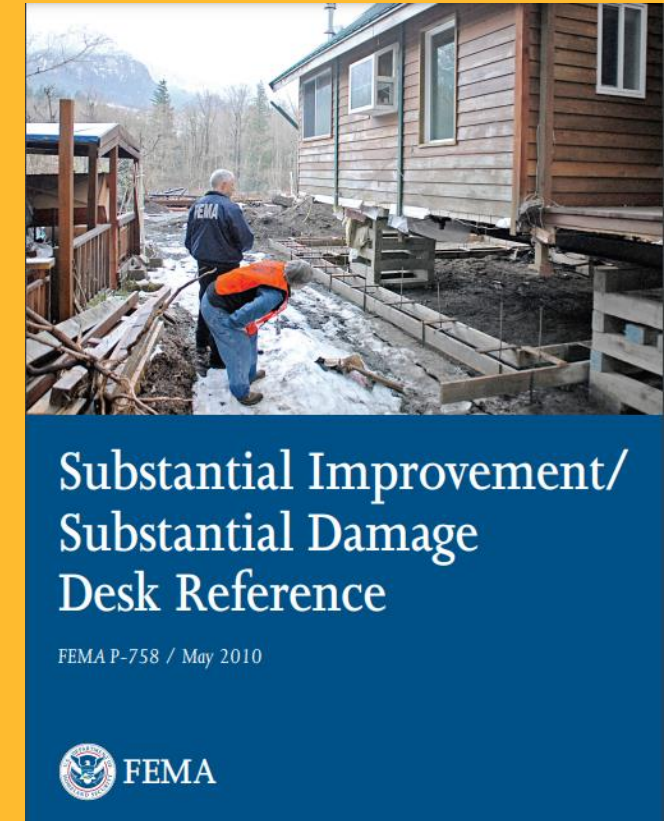
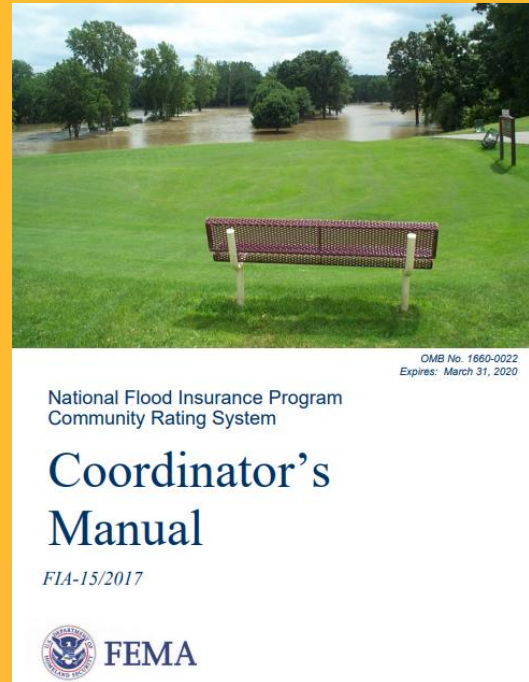

National Pollution Discharge Elimination System (NPDES)

❖ What is NPDES

- ❖ Permit issues by MDNR, under authority of EPA, based on 1987 Clean Water Act Amendment
- ❖ Reduce pollution in “non-point source” water, which is stormwater runoff
- ❖ 5-year permit that authorizes City of Lee’s Summit to operate a stormwater collection

❖ NPDES permit requires a Stormwater Management Plan, Recordkeeping, Reporting

MDNR = Missouri Department of Natural Resources

EPA = Environmental Protection Agency

NPDES Permit sometimes referred to as “MS4” permit

MS4 = Municipal Separate Storm Sewer System

What does the NPDES Regulate ?

❖ 6 Minimum Control Measures (MCMs)

- ❖ Public Education and Outreach on Stormwater Impacts
- ❖ Public Involvement and Participation
- ❖ Illicit Discharge Detection and Elimination (IDDE)
- ❖ Construction Site Stormwater Runoff Control (erosion control)
- ❖ Post-construction Stormwater Management Plan in New Development and Redevelopment
- ❖ Pollution Prevention / Housekeep for Municipal Operations

❖ Permit requires Annual Report submitted to MDNR

❖ Permit requires a summary or report submitted to governing body

FEMA National Flood Insurance Program (NFIP)

❖ 3-legged Stool

- ❖ Know the risk (Mapping)
- ❖ Mitigate the risk (permitting; regulations)
- ❖ Insure the Risk (flood insurance)

❖ Community Rating System (CRS)

- ❖ Voluntary program to lower insurance rates
- ❖ Community scores points based on local standards and practices

Why Have a Substantial Damage Plan

❖ Substantial damage:

- ❖ Damage to structure, and cost to repair, exceed 50% of the value of the structure
- ❖ Substantial damage requires bringing older structure in compliance with NFIP
- ❖ Substantial damage practice is required by NFIP

❖ Substantial Damage Plan

- ❖ Writing the plan scores points in CRS to help lower local insurance rates
- ❖ The written plan merely documents what City staff already does
