Missouri Statute 311.2026 was revised due to the upcoming 2026 FIFA World Cup festivities. The Police Department recommends to opt out of these provisions.

Major Walters is in communication with local businesses who voiced concerns about not being able to stay open later. A survey was sent to over 100 businesses (with 15 responses) to see who would participate in extended hours.

In order to work with the businesses, the Police Department proposed Substitute Bill No. 25-230 to allow the businesses to stay open and serve alcohol an extra hour during specific dates and times of the World Cup Tournament.

Council was neither for nor against, but preferred the Substitute Bill be added to the January 6, 2026 council meeting for a vote.
