

## **BILL NO. 25-217**

AN ORDINANCE APPROVING THE PURCHASE OF A VIRTUAL REALITY TRAINING SYSTEM FROM V-ARMED, INC. FOR AN AMOUNT NOT TO EXCEED \$351,000.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit issued a request for proposals to provide the Police Department with a virtual reality training system; and,

WHEREAS, V-Armed, Inc. provides virtual reality training systems; hardware, software, and peripheral devices and support services for use by law enforcement agencies and submitted the most advantageous bid in response to the request for proposal; and,

WHEREAS, funding to support the purchase has been identified in the voter approved Public Safety Sales Tax; and,

WHEREAS, the City wishes to purchase from V-Armed the virtual reality training system products and services listed in the attached Agreement and V-Armed desires to provide the products and services to the City in accordance with, and subject to, the terms and conditions set forth in the attached Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The V-Armed Virtual Reality Training System Purchasing and Services Agreement and attachments by and between the City of Lee's Summit, Missouri and V-Armed, Inc., a true and accurate copy being attached hereto as "Exhibit A" and incorporated herein by reference be and the same is hereby approved.

SECTION 2. The City Manager is authorized to execute the V-Armed Virtual Reality Training System Purchasing and Services Agreement attached hereto as Exhibit A on behalf of the City of Lee's Summit, Missouri, and to make such changes in the agreement as are necessary to achieve the intent and purposes of this Ordinance so long as the total amount of compensation does not exceed the amounts set forth in Exhibit B of the contract.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
