AN ORDINANCE ESTABLISHING POLICES, GUIDELINES, RULES, REGULATIONS AND MINIMUM STANDARDS FOR COMMERCIAL AND NON-COMMERCIAL OPERATIONS AT THE KANSAS CITY – LEE’S SUMMIT REGIONAL AIRPORT.

WHEREAS, the City of Lee’s Summit, Missouri, is the sponsor of the Kansas City – Lee’s Summit Regional Airport (“Airport”); and,

WHEREAS, as the sponsor of the Airport, the City is obligated to abide by Federal Grant Assurance, as promulgated and enforced by the Federal Aviation Administration (“FAA”); and,

WHEREAS, the Federal Grant Assurances establish guidelines and protocols for activities associated with the Airport; and,

WHEREAS, the FAA guidelines and policies permit the City to identify and operate facilities based on the proprietary interests of the City; and,

WHEREAS, the FAA encourages airport sponsors to enact and enforce rules and regulations and minimum standards; and,

WHEREAS, the City is committed to providing the best possible aeronautical services to the public through consistent planning and development practices and the enforcement of uniform rules and regulations; and,

WHEREAS, the City Council has determined that the proposed policies, guidelines, rules, regulations, and minimum standards will serve the interests of the users of the Airport and the citizens of Lee’s Summit.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Rules and Standards for the Kansas City – Lee’s Summit Regional Airport, attached hereto as Exhibit A and incorporated by reference, are hereby approved and adopted.

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. It is the intention of the City Council and is hereby ordained that the provisions of this Ordinance shall become effective and in full force and effect from and after the date of its passage, adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
