11. Committee Reports

Councilmember Forte advised the special meeting of the Community and Economic Development Committee scheduled for March 25, 2020 has been cancelled. It is unknown at this time if the April meeting will be held.

Councilmember Faith stated the Public Works Committee has a meeting currently scheduled for April 6, 2020. They are continuing to monitor the situation and will determine if their business items are crucial enough to warrant holding the meeting. They plan to make a decision in the following few days.

12. Council Comments:

Councilmember Binney asked if the state is under a disaster order and a state of emergency. He said the SBA (Small Business Association) is talking about a loan assistance program but it states the Governor has to make a disaster program declaration. Mr. Dan Manley, Assistant Fire Chief, reported the state of Missouri did issue a Gubernatorial declaration last week. He added that information was received today from the State Emergency Management Agency

(SEMA) identifying information about small business administration applications. That information was communicated to the Lee's Summit Chamber of Commerce and Downtown Main Street. It has also been posted on the community page for information on the COVID-19 response.

Councilmember Binney then asked if the purchase of sanitizing equipment approved at tonight's meeting is just for the use of Public Safety personnel or will it become available for public use. Mr. Manley explained the piece of equipment will be for disinfecting city apparatus, vehicles, ambulances, police cars, and public facilities. It is an aerosolization devise that uses a hospital grade disinfectant and breaks it down to a level that is able to have greater penetration of hard and some soft surfaces.

Councilmember Faith asked if Lee's Summit Firefighter's with their SCBAs share masks. Mr. Mike Snider, Fire Chief, stated mask's are assigned individually.

Councilmember DeMoro asked how city vehicles and facilities are being disinfected now, before the purchase of sanitizing equipment approved tonight. Chief Snider stated CDC guidelines are being followed to include using hospital grade disinfectant and limiting the number of personnel that would interact with that scenario. Councilmember DeMoro then asked how an emergency response would be handled for a person showing symptoms of COVID-19 and what precautions would staff use. Chief Snider replied the standard equipment recommended by the CDC for this virus, and other viruses, is they have face and eye protection, gloves and a gown. A surgical mask would also be given to the patient to place on themselves. He added, these are the same precautions that would be used for any typical virus.

Mayor Baird stated staff is giving it their all and asked Council to continue practicing social distancing and being good role models.

13. Staff Roundtable

Mr. Steve Arbo, City Manager, reviewed the stages of the Emergency Management Plan (EMP) that has been put into place which included travel bans for employees, the closures of some public facilities, cancellation of all special events and meetings, and online services available. Water disconnects have been suspended until further notice and payments can still be put in the drop box. Changes to the plan could change daily.

Mr. Brian Head, City Attorney, informed the City Council that a petition was filed by 45 counties in the western district asking to delay the April election until June 2, 2020. There is a provision in the Missouri Constitution in Article 4, Section 2, that states an office holder will continue to hold office for the term thereof or until their successor is duly elected or appointed and qualified so current Councilmembers with expiring terms will continue to serve until a

successor is elected and duly qualified.

14. Adjournment

Hearing no further business, Mayor Baird adjourned Regular Session No. 53 at 8:22 p.m.
