AN ORDINANCE APPROVING CHANGE ORDER NO. 8 TO THE AGREEMENT FOR THE 3RD STREET IMPROVEMENTS FROM BLUE PARKWAY TO JEFFERSON STREET PROJECT, PROJECT NO. 575, BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND MILES EXCAVATION, INC., TO INCREASE THE PROJECT TIMELINE BY TWO DAYS AND CONTRACT AMOUNT BY \$16,392.81 AND TO ADJUST ITEM QUANTITIES DUE TO ADDITIONAL WORK FROM ADDENDUM NO. 1, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 10033, the City and Miles Excavating, Inc. ("Contractor") entered into an agreement for the construction of the 3rd Street Improvements from Blue Parkway to Jefferson Street Project, Project No. 575 ("Base Agreement"); and,

WHEREAS, the City and Contractor modified the Base Agreement, as amended, per Change Orders 1 through 7 administratively in accordance with the City's Procurement Policy; and,

WHEREAS, the City desires to further modify the Base Agreement, as amended, to adjust the construction contract time and price to allow for changes needed on Addendum No. 1.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. Change Order No. 8 to the Base Agreement, as amended, attached hereto and incorporated herein by reference as Exhibit A, with the Contractor, an increase the contract price by \$16,392.81 and project timeline by two days due to additional work from Addendum No. 1, is hereby approved and the City Manager, or designee, is hereby authorized to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
