AN ORDINANCE AUTHORIZING THE EXECUTION OF A BREAK IN LIMITED ACCESS LICENSE AGREEMENT BETWEEN THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION AND THE CITY OF LEE'S SUMMIT, MISSOURI, FOR A BREAK IN ACCESS ON M-291 HIGHWAY

WHEREAS, the City owns and has exclusive right to possession, use, and control of certain real estate in Lee's Summit, in Jackson County, Missouri; and,

WHEREAS, by a deed recorded electronically in Instrument Number 2016E0097483, in the Office of the Jackson County Recorder of Deeds, all right of access between said state highway and the City's abutting land in Lee's Summit was restricted to a certain location (or locations) therein set out; and,

WHEREAS, the City now requests and the Commission is willing to allow the City access to Route 291 as hereinafter set out; and,

WHEREAS, the parties are authorized to enter into such agreements pursuant to Section 70.220 of the Revised Statutes of Missouri; and,

WHEREAS, Section 70.230 of the Revised Statutes of Missouri provides that the parties may enter into such agreements by ordinance duly enacted.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. That the Break in Limited Access License Agreement between the Missouri Highways and Transportation Commission and the City of Lee's Summit, Missouri, attached hereto and incorporated herein by reference, is hereby approved and the City Manager is authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 2. That this ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
