AN ORDINANCE APPROVING A TRANSPORTATION ALTERNATIVES PROGRAM AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION RELATED TO THE PUBLIC IMPROVEMENT PROJECT DESIGNATED AS FEDERAL PROJECT NUMBER TAP 3448(402), SE DOUGLAS STREET – BLUE PARKWAY TO 4^{TH} STREET, WITHIN THE CITY LIMITS OF LEE'S SUMMIT, MISSOURI AND AUTHORIZING THE MAYOR TO EXECUTE THE SAME.

WHEREAS, the SE Douglas Street Improvements project ("Project") was authorized by voters as part of the April 2023 No Tax Increase Bonds for transportation projects; and,

WHEREAS, the City Council formally programmed funding for the Project as part of the FY2025 Capital Improvement Plan (CIP); and,

WHEREAS, the Missouri Highways and Transportation Commission ("MoDOT") approved the City's submittal of the Project for Transportation Alternatives Program federal funding in the amount not to exceed \$1,500,000 ("Federal Project Number TAP 3448(402)"); and,

WHEREAS, an agreement between the City and MoDOT is necessary to memorialize the mutual covenants, promises, and representations for Federal Project Number TAP 3448(402) for Transportation Alternatives Program ("TAP Funding Agreement").

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

- SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves the TAP Funding Agreement as attached hereto and incorporated herein as "Exhibit A".
- SECTION 2. The Mayor is hereby authorized to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.
- SECTION 3. The Mayor, City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.
- SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
- SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
