### 3. Council Roundtable

Councilmember Binney reported that he attended the Missouri Municipal League (MML) State Board of Directors meeting last week and there was good discussion regarding Proposition D. A lot of good things went on around the state and there is still a lot of respect for the things being done in Lee's Summit.

**5. Public Comments:**

Ms. Geraldine Amato shared her opinions on several topics related to the Federal Government.

Mr. Keith Foster addressed the Council regarding the North Park Village storm water basin and the issues it has caused on his property.

Mr. Dennis Klein, owner of 50 Hwy Storage, spoke regarding the proposed storage facility on the agenda. It would negatively impact his business by at least 30%. There are existing Class A facilities in Lee's Summit and none of them are full. If approved, this would be the 11th storage facility in a 4 mile radius. Only 2-3 jobs would be created, these facilities don't charge sales tax and property tax would be negated by less property taxes from surrounding properties. Many variances to the UDO have been requested.

Mr. Chris Maddox, Attorney representing the Super 8 Motel, spoke in opposition to the proposed storage facility. He sighted requirements of a Special Use Permit are designed to keep the project from view but this project is designed to be seen and they even requested additional signage. Some customers at the hotel will then have a bright neon sign directly out of their window and the second floor of the storage facility is all windows with lights left on 24/7. The hours of operation would be 6:00 a.m. to 10:00 p.m., and the trash enclosure abutts up to the western property line.

Mr. Mike Collier, Regional Manager for Perkins Restaurant and Bakery, stated his opposition to Bill 18-116 and 18-117, sighting traffic and parking issues that already exist on the service road on the weekends. Storm water from the development on the south side of 50 Highway runs under the highway and into the subdivision where he lives and has caused hardships to the homeowners over the years. Recently, FEMA has declared them in a flood zone so they now have to purchase flood insurance.

Mayor Baird thanked Johnathon, a Boy Scout from Troop 262 for attending.
