 - Different requirements to different developers can cause

issue

- Cross benefit analysis
- No debt being requested of the City
- PILOTS and sales tax increase
- CID tax only affects citizens if they “shop” in that area - not a city-wide tax
- Would not divert any tax revenues from the City
- Reimbursement from public improvements
- Property tax abatement
- Tenants - industrial tenants planned only at this time. Not sure about the others
- Current road costs to maintain? \$20k per year
- Piecemeal would also affect the timeline and impacted infrastructure
- No additional tax abatements when tenants come in
- Traffic issues
 - Decade long process
- Economic activity
- Office and retail
- Master development agreement
- Preference by church as the seller of the property to sell to one developer or pieces and completing infrastructure in steps
 - One developer
- Does not generate any new taxes unless shopping in this area
- Not funded by general revenues of the City
- Land Reserve owns the property - not the City
 - Land Reserve can sell to anyone and can be developed under the codes of the city.
