AN ORDINANCE APPROVING MODIFICATION NO. 2 TO AN AGREEMENT DATED JULY 16, 2019, (RFQ NO. 543-32272B) FOR PROFESSIONAL ENGINEERING SERVICES FOR STORMWATER – SE HACKAMORE DRIVE & SE SECRETARIAT DRIVE WITH INTUITION & LOGIC, INC., FOR AN INCREASE OF \$64,690.10 WITH AN AMENDED NOT TO EXCEED AMOUNT OF \$324,334.30, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 8866, the City and Intuition & Logic, Inc. entered into an Agreement (hereinafter “Agreement”) dated July 16, 2019, (RFQ No. 543-32272B) for Professional Engineering Services to address structural flooding of properties along SE Hackamore Drive and SE Secretariat Drive (hereinafter “Base Agreement”); and,

WHEREAS, Intuition & Logic, Inc. (hereinafter “Engineer”) has submitted a proposal to provide design and construction services for flood proofing 4409 SE Secretariat Drive and upgrading the enclosed storm system near the 200 block of SE Hackamore Drive; and,

WHEREAS, the City desires to modify the Base Agreement with Engineer to provide for this additional scope of engineering and construction services (hereinafter “Modification No. 2”).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee’s Summit, Missouri, hereby approves Modification No. 2 of the Agreement with Engineer for an increase of \$64,690.10 with an amended not to exceed amount of \$324,334.30, as attached hereto as “Exhibit 1”.

SECTION 2. That the City Council of the City of Lee’s Summit, Missouri, hereby authorizes the City Manager to execute the same on behalf of the City of Lee’s Summit, Missouri.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
