

BILL NO. 23-038

AN ORDINANCE AMENDING SECTION 29-41 OF THE CODE OF ORDINANCES FOR THE CITY OF LEE'S SUMMIT, MISSOURI, GOVERNING THE PUBLIC SAFETY ADVISORY BOARD ESTABLISHMENT AND DUTIES.

WHEREAS, the City Council recently amended Division 1, Article V. Boards, Commissions, and Committees of Chapter 2. Administration, of the Code of Ordinances of the City of Lee's Summit Missouri, by enacting fourteen (14) new sections thereof dealing generally with rules for the conduct of business by city boards, commissions and committees; and,

WHEREAS, the language in amended Section 2-264 A, states a member of the City Council may be appointed to each board, commission, or committee, as a non-voting City Council liaison; and,

WHEREAS, section 29-41 currently states, one (1) member of the Council shall serve as liaison, with voting rights, appointed by the Mayor Pro-Tem with the advice and consent of a majority of the Council; and,

WHEREAS, the City of Lee's Summit seeks to update the language in Section 29-41 to match the newly amended Division 1, Article V, Chapter 2.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. Section 29-41, A, shall be amended to now read as follows:

Sec. 29-41. Public Safety Advisory Board established; duties.

- A. The Public Safety Advisory Board is hereby established.
1. The Board shall consist of nine (9) citizen members, appointed by the Mayor with advice and consent of a majority of the Council.
 2. One (1) member of the Council shall serve as liaison, without voting rights, appointed by the Mayor Pro-Tem with the advice and consent of a majority of the Council.
 3. Citizen members shall serve three-year terms, which shall be staggered.
 4. The Board shall elect a Chair and Vice-Chair annually following the annual appointments to the Board. Citizen Board members shall serve without compensation.
 5. Board meetings shall be open to the public and shall be conducted pursuant to the Missouri Sunshine Law, RSMo. 610.010, et seq., as amended Robert's Rules of Order shall govern procedural matters of the Board.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
