Interest Response: I have lived in Lee Haven Apartments for over five years with my 23year-old autistic son. I am confined to a wheelchair. In January 2025, I began studying the HUD Guidelines and Federal Regulations involved in starting a Resident Council in my community. Including an online social media presence. That did not get enough support to continue. I am now a member of the Resident Advisory Board for LSHA. I'll be making suggestions, with the rest of the residents on the RAB, for the annual plans and the five-year plan LSHA must submit this year for funding in 2026 and beyond. The plans are one of the top priorities for LSHA at this time. I'm proud to represent both LSHA and the residents of all public housing properties.

I know an adequate amount of information about HUD and I received my Paralegal Certification in 1986; statues and regulations are not new to me. Both in Judicial and Administrative Law. My background is with the MO Division of Social Services Child Support Enforcement. I did case work that involved skills in mediating problems, offering suggestions, and coming to agreements on the subject of Child Support. I also enforced child supports laws for Jackson County, MO. I have good people skills and usually can find common ground between disputes. I also spent a year in the Div of Family Services and another year caring for abused children in a temporary group home for ages 2-16 years. We got the kids directly from law enforcement and kept them until foster or group homes were found. I can deal with pressure. Most of my working life I worked for the State of MO. I also understand the importance of following Federal, State, and Municiple regulations.

The birth of my son in 2002 left no time for volunteer work. I raised two children alone, went to school full time, and worked full time.
