AN ORDINANCE APPROVING A LEASE-PURCHASE FINANCING AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND STRYKER MEDICAL FOR THE PURCHASE OF NEW LIFEPAK DEFIBRILATOR MONITORS FOR THE FIRE DEPARTMENT, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit (the "City") is a political subdivision of the State Missouri in which City is located and is duly organized and existing pursuant to the constitution and laws of the State of Missouri; and,

WHEREAS, the City's fire department has a need to replace its compliment of Lifepak Defibrillator monitors; and,

WHEREAS, to ensure the best use of City funds, the City reviewed various options to finance the purchase of the monitor defibrillators. The City determined a lease-purchase financing agreement was the best option; and,

WHEREAS, Stryker Medical utilizes an approved cooperative purchasing agreement guaranteeing competitively bid pricing and,

WHEREAS, the City desires to enter into an agreement with Stryker Medical for the purchase of 25 Lifepak 35's; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if a City contract has or is anticipated to have an annual spend of \$75,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council hereby approves the award of a lease purchase agreement to Stryker Medical.

SECTION 2. The City Council approves an agreement between the City and Stryker Medical. ("Contract No. 2024-_____"), attached as Exhibit A and incorporated herein by reference, to finance the purchase of Lifepak 35's in the amount not to exceed \$1,436,388.00 paid over 7 annual payments of \$252,148.27, and authorizing the City Manager to execute the same, in substantially the same form as the attached, and any other documents necessary to carry out the intent of this ordinance, on behalf of the City.

SECTION 3. The City's obligations under Contract No. 2024-_____ shall be subject to annual appropriation by the City Council as set forth in Contract No. 2024-_____, and the City's obligations under Contract No. 2024-_____ shall not constitute a general obligation of the City or indebtedness under the constitution or laws of Missouri.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
