A RESOLUTION CANVASSING AND DECLARING THE RESULTS OF THE APRIL 2, 2024, REGULAR MUNICIPAL ELECTION FOR MUNICIPAL OFFICERS FOR THE CITY OF LEE'S SUMMIT, MISSOUR.

WHEREAS, a Regular Municipal Election was held in the City of Lee's Summit, Missouri, on April 2, 2024; and,

WHEREAS, the official return of the election has been received from the Jackson County Board of Election Commissioners, certified by such board; and,
