Interest Response: I recently learned about the Wellness Commission through Dr. Ed Kraemer. I have been with Saint Luke's Health System for 15 years and have held a variety of positions while there, including Director of Marketing for Saint Luke's East Hospital and Director of Foundation Relations for the Saint Luke's Foundation before moving into my current position with our population health team two years ago. At Saint Luke's, population health is part of our primary care team. Our purpose is to help our patients meet their health goals and to achieve health equity, where every patient has a fair opportunity to have the best health outcome possible. As the strategy consultant, I work on programs to directly impact our patients who experience social drivers of health, such as food, housing, and transportation insecurity and social isolation. The population health team is also responsible for conducting Saint Luke's community health needs assessments and community health improvement plans. As a resident of Lee's Summit and an employee of Saint Luke's, I have a vested interest in the well-being of our community. While Lee's Summit is an overall prosperous area, there are citizens in our community who experience health inequities and have poor health outcomes. The work to improve the health of our community can't be done by one organization alone. It will take cross-sector collaboration of health care, government, community-based organizations and private business to understand the community's needs and enact programs and policies to have meaningful impact. With my role in population health, I can help the wellness commission and the city understand the health needs we are seeing in our community and the trends we are seeing among our

patients, which can help inform the focus of the commission and the work it plans to carry out. I also have experience building programs from conception to implementation. This past year I designed a Produce Prescription Program pilot, which is a collaboration with Saint Luke's and Kanbe's Markets to increase access to fresh produce for patients with dietrelated conditions such as obesity, hypertension, and diabetes. And I'm in process of launching a transportation pilot for primary care patients in our Lee's Summit and Independence clinics.
