B. 2023-5410 Public Hearing: Community Development Block Grant Annual Action Plan for Program Year 2023-24

Sarah Tilbury, CDBG Administrator, presented an overview of the 2023-24 CDBG Annual Action Plan, timeline, funding caps and prioritization process. This year HUD is allocating \$354,909 for the program which is an increase of \$21,500 from last year's funding. Ms. Tilbury also stated there is a surplus of \$16,552.90 from prior year CDBG activities which staff is recommending to be reallocated to the 2023-24 program year for a total funding amount of \$371,461.90.

A representative from each of the following organizations presented information about their funding requests and staff shared their recommendations of the requests followed by discussion. After discussion, the CEDC made the following amendments to staff's recommendations (noted in red). They agreed to remove staff's recommendation of \$67,725.55 from the Planning/Administration category and add it to the requests from Lee's Summit Social Services and Truman Heritage Habitat.
