Mayor would like the document to show what Lee's Summit and the other Cities have to offer. He specifically mentioned growth, community, residential and family.

Staff was directed to put together a draft of the priorities with headings and bullet points.

Producing positive outcomes for the citizens of Lee's Summit is a top priority. We will remain proactive with monitoring proposals that can negatively impact the City.

The City will work in coordination with organizations such as the Missouri Municipal League, Mid-America Regional Council, Lee's Summit Chamber of Commerce on objectives and goals of the City.

# MUNICIPAL AUTHORITY

- Preserve local control of municipal right-of-way and properties
- Maintain local control of placement and permitting of telecommunications infrastructure
- Maintain municipal authority of residential short term rental
- Strengthen Sunshine Law provisions to protect personal privacy data of municipal employees

# REVENUE

- Eliminate or reduce unfunded mandates
- Preserve local control over municipal revenue sources
- Support opt-in provisions for sales tax exemptions

- Enact legislation implementing destination sales taxation as discussed by the U.S. Supreme Court Wayfair decision
- Support video franchise legislation that protects municipal revenue

# TRANSPORTATION

- Encourages legislation to allocate direct funding for roads within Lee's Summit as part of cost-sharing projects
- Support funding for improvements to Highway 50 and 291 North interchange
- Support funding for improvements to Highway 50 and 3rd Street interchange
- Maintain funding for airport improvements

# ECONOMIC DEVELOPMENT

- Continuation of funding for tax credit programs
- Maintain local authority over economic development programs and tools
- Supports amendment to the CID act to allow use of CID funds outside of district boundaries
- Support economic development tools to encourage next generation and high tech businesses
- Long term continuation and expansion of workforce development efforts through local partnerships
- Encourage support for continued investment in the arts, tourism and recreation
