## **BILL NO. 21-249**

AN ORDINANCE APPROVING THE AWARD OF BID NO. 2022-029, TO PURCHASE ELECTRICAL SERVICES AND MATERIALS ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO GREENWOOD ENERGY SOLUTIONS, LLC, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2022-029 ("Bid") for electrical services and materials; and,

WHEREAS, the Bid was advertised through the City's e-procurement system, Public Purchase, and sent to 42 potential bidders; and,

WHEREAS, at the close of the Bid three (3) bidders had submitted responsive and responsible bids; and,

WHEREAS, based upon the evaluation of responses and bid criteria, the City recommends awarding the Bid to Greenwood Energy Solutions, LLC; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if a City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's award of Bid 2022-029 to Greenwood Energy Solutions, LLC to purchase electrical services and materials.

SECTION 2. The agreement between the City and Greenwood Energy Solutions, LLC, attached as Exhibit A and incorporated herein by reference, to purchase electrical services and materials is approved, and the City Manager is authorized to execute the same in substantially the same form as the attached on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
