AN ORDINANCE APPROVING THE DUAL AWARD OF BID NO. 2022-14, TO PURCHASE WATER METERS ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO CORE & MAIN, LP AND MIDWEST METER, INC AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2022-014 ("Bid") for displacement and compound water meters of various sizes; and,

WHEREAS, the Bid was advertised through the City's e-procurement system, Public Purchase, which notified 135 potential bidders; and,

WHEREAS, at the close of the Bid two (2) bidders had submitted responsive and responsible bids: and.

WHEREAS, based upon the evaluation of responses and bid criteria, the City recommends awarding of the Bid to Core & Main, LP for meters 2" and larger and Midwest Meter, Inc. for meters less than 2"; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if a City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's dual award of Bid No. 2022-014 to Core & Main, LP for the purchase of water meters 2" and larger and Midwest Meter, Inc. for the purchase of water meters less than 2".

SECTION 2. The Agreements between the City and Core & Main, LP, attached as Exhibit A and incorporated herein by reference, and between the City and Midwest Meter, Inc., attached as Exhibit B and incorporated herein by reference, are approved, and the City Manager is authorized to execute the same in substantially the same form as the attached, on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
