## BILL NO. 22-43

AN ORDINANCE APPROVING AMENDMENT NO. 6 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2022, AS ADOPTED BY ORDINANCE NO. 9184 AND ORDINANCE NO.9187, BY AMENDING THE AUTHORIZED EXPENDITURES TO PROJECTED YEAR END AMOUTNS FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Ordinance No. 9184 and Ordinance No. 9187, passed by the City Council on June 16, 2020, adopted the authorized expenditures for the City of Lee's Summit; and,

WHEREAS, the annual budget planning process includes a period for reviewing and revising anticipated expenditures for the current fiscal year; and,

WHEREAS, it is necessary to increase funding to certain projected expenditure levels to deliver municipal services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2022, of the City of Lee's Summit, Missouri, are amended in the following manner:

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
