

BILL NO. 22-56

AN ORDINANCE RATIFYING AN EMERGENCY PURCHASE FOR WATER LINE CONSTRUCTION WITH WIEDENMANN CONSTRUCTION FOR \$59,511.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME.

WHEREAS, Section 7.1 of the City's Procurement Policy allows the City to make certain purchases before receiving City Council approval when an emergency exists; and,

WHEREAS, a City of Lee's Summit water line is encroaching on the property located at 890 NE Langsford Road without an easement; and,

WHEREAS, this water line is in direct conflict with the foundation of a proposed Chase Bank building; and,

WHEREAS, Chase Bank ("Bank") and the City have agreed to have the City move the water line to a location away from this construction; and,

WHEREAS, the City received quotes from the Bank's Contractor and the City's on-call Contractor, Wiedenmann Construction; and,

WHEREAS, the Wiedenmann quote was less than that of the Bank's Contractor and City desires to engage Wiedenmann Construction to perform the work; and,

WHEREAS, this project has been deemed an emergency in order to keep the Bank on schedule and limit the City's liability; and,

WHEREAS, pursuant to Section 7.1 of Procurement Policy, emergency purchases in an amount of \$50,000 or more must be presented to the City Council for ratification at the earliest opportunity after the purchase has been made.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, ratifies the emergency purchase in the amount of \$59,511.00, contained in the quote attached hereto as Exhibit 1 and ratifies the City Manager's execution of documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
