#### 1. Call to Order

Chair Forte called the April 11, 2022 Community and Economic Development Committee meeting to order at 5:02 p.m.

Councilmember Carlyle joined the meeting at 5:06 p.m.

#### 3. Approval of Agenda

A motion was made by Vice Chair DeMoro, seconded by Councilmember Felker, to approve the agenda as posted. The motion carried by a 3-0 unanimous vote (Councilmember Carlyle joining the meeting at 5:06 p.m.).

#### 4. Public Comments

There were no public comments.

#### 5. Business

A. 2022-4807 Approval of the March 9, 2022 Community and Economic Development Action Letter

A motion was made by Councilmember Felker, seconded by Vice Chair DeMoro, to approve the Community and Economic Development Committee Action Letter dated March 9, 2022. The motion carried by a unanimous 3-0 vote (Councilmember Carlyle joining the meeting at 5:06 p.m.).

B. <u>BILL NO.</u> <u>22-85</u> An Ordinance amending Chapter 4, Alcoholic Beverages, Article III. Licenses, Division 2 Types of licenses; Fees, of the Code of Ordinances of the City of Lee's Summit, Missouri to revise the provisions relating to Sunday hours of sales in accordance with State law. (CEDC 4/13/22)

Mark Dunning, Assistant City Manager, explained that the Missouri State Legislature has changed their provisions regarding liquor sales by expanding the hour of sales to 6:00 a.m. on Sundays until 1:30 a.m. on Mondays. The City of Lee's Summit desires to amend Chapter 4 Alcoholic Beverages to be in alliance with the State revisions in the Liquor Control Law for the efficient administration and regulation of alcoholic beverages within the city.

A motion was made by Vice Chair DeMoro, seconded by Councilmember Carlyle, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 4-0 vote.

**C.** BILL NO. 22-86

An Ordinance amending the Code of Ordinances of the City of Lee's Summit, Missouri by enacting a new Section 17-62. Child Abuse., providing generally for the creation of the offense of Child Abuse and specifying the penalty for violation. (CEDC 4/13/22)

Brian Head, City Attorney introduced Abby Pennell, the new City Prosecutor, who explained that most child abuse cases in Lee's Summit were being presented as child endangerment cases. Adopting a child abuse ordinance will help ensure these cases are handled appropriately.

A motion was made by Vice Chair DeMoro, seconded by Councilmember Carlyle, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 4-0 vote.

**D.** BILL NO.22-87

An Ordinance amending the Economic Development Incentive Policy by incorporating policy statements relating to incentive requests for residential development for the City of Lee's Summit, Missouri. (CEDC 4/13/22)

Mark Dunning, Assistant City Manager, provided background on this ordinance and reviewed the feedback from the CEDC regarding the use of incentives for residential developments. Discussion ensued and staff answered questions from the committee.

A motion was made by Councilmember Felker, seconded by Councilmember Carlyle, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 4-0 vote.

Councilmember Felker asked about the timeline for a comprehensive review of the Economic Development incentives. Mark Dunning replied it would be brought to a future CEDC meeting.
