At the same time, it is disappointing to see one of the most important safety improvements being delayed until the last year (2027) of the current CIP plan (2023-2027). That improvement is the addition of an air traffic control tower. The primary purpose of air traffic control towers is to enhance safe aircraft operation on and around airports and to expedite the safe arrival and departure of air traffic. Additionally, air traffic control tower operators can have a considerable influence on how pilots fly traffic patterns and the way they maneuver their aircraft during approach and departure procedures which in turn, can help minimize noise levels. All of this is even more important at an airport such as ours in Lee's Summit which has such a broad mix of aircraft having dramatically different operation speeds. I would strongly encourage all parties to consider accelerating the funding and construction of this important safety item.	As part of the Phase 2 Airport Master Plan Update, an Air Traffic Control Tower, ATCT, feasibility study is currently be completed. At certain aircraft traffic volumes and mix of use, i.e., general aviation and corporate aviation, an ATCT will serve to increase safety for arriving and departing aircraft, as well as ground operations. It is fully anticipated the Lee's Summit Municipal Airport will qualify for the FAA's Contract Tower Program. In fact, a grant application has been submitted to the FAA for the construction of an ATCT. At the same time, however, we must be realistic in how the Lee's Summit Airport, LXT, will compete for those limited funds. While we do think the airport will compete fairly well, it is more realistic the ATCT will compete more favorably a few into the five-year plan. The City's Greenway Master Plan and Greenway Trail System show a side path proposed along Independence Avenue. That work is unfunded.
